TERMS AND CONDITIONS

PROPOSAL ACCEPTANCE: Acceptance of all tour proposals and itineraries **must be signed** and agreed to by the Director and in our office no later than 30 days after the offer. Later acceptance may cause price revisions. Price revisions can occur when the number of paying travelers varies and/or with transportation fuel and surcharges. All invoices for the tour will be made through the school and the amounts reflected in this agreement will determine the final invoice.

GROUP DEPOSIT: A non-refundable group deposit is required. The deposit will be credited to the tour's invoice balance.

PAYMENT SCHEDULE: 4 Payments - see attached Proposal Agreement Form. (Schedule to be determined at time of deposit)

FINAL PAYMENT: **Final payment of the balance of the trip cost is due no later than 30 days prior to departure.** A 2-% penalty shall be assessed weekly on any outstanding balance not paid by 30 days prior to departure. No trip commences until the World View Travel (WVT) receives final payment in full.

CANCELLATION POLICY: the director of the group must submit Cancellations in writing to WVT. All refunds shall be subject to the following policy:

\$150 Deposit is NON-REFUNDABLE

Cancellation before 90 days prior to departure - will incur a \$25 per person cancellation fee and will result in the proportionate loss of the group deposit plus any fees levied by hotels, transportation companies, and other retailer and vendors.

Cancellation before 45 days prior to departure - will incur a \$50 per person cancellation fee and will result in the proportionate loss of group deposit plus any fees levied by the hotels, transportation companies, and other retailers and vendors.

Cancellation after April 1 payment has been made - no refund will be given. If the total amount has been received, unused airline tickets will be returned to the director. Any further dealings with unused tickets will be between the ticket holder and the Airline Company. In the event WVT should cancel the tour, the group will receive a full refund including the group deposit.

“These payment timelines and non-refundable dates are in effect regardless of the eligibility of the student” - STUDENTS MUST BE ELIGIBLE AT THE END OF THE 5th SIX WEEKS (APRIL 17, 2009)

LIABILITY AND RESPONSIBILITY

WVT gives notice that all arrangements for transportation or conveyance or for hotel accommodations and all tickets and coupons issued by them, are made by them as agents upon the express condition that they shall not be liable for any injury, damage, loss, accident, delay or irregularities which may be occasioned either by reason of defect in any vehicle, or through the acts of default of any company or person engaged in conveying the passenger, or in carrying out the arrangements of the tour(s), or otherwise in connection therewith, or any hotel proprietor or servant.

World View Travel accepts no responsibility for losses or additional expenses due to delays or changes in bus, train, steamer, or other services, sickness, weather, strikes, war, quarantine, or other causes, or act of God. I, the Director, agree to release WVT, its agents and employees from all claims arising out of such events, acts or omissions.

I understand that WVT has offered these tours and itineraries based on fares and prices at the time of offering, and grant WVT the right to change, add or withdraw any tour announced in its publications or group proposals and to make alterations in the itineraries and program costs as may be found necessary due to change in transportation costs, exchange rates, lack of participation or program costs. All fares are based on present value of local and foreign currencies and in current tariffs and are subject to confirmation and/or adjustment when payment for the tour is made. I understand that such changes in the program, including increases in program prices, are not grounds for withdrawal with full refund, except as noted in stated cancellation policy.

I understand that WVT reserves the right to impose any rules or standards that it announces to its participants. Failure to comply with said standards and rules could mean immediate termination of my participation in the program. Costs due to termination are at the Director's expense and unused portions of my program may not be refundable. It is also agreed upon that any use of alcohol by minors or the use of illegal drugs is grounds for rejection from the tour program. WVT is not responsible for my or any group member's well-being. The right is also reserved by WVT to decline to accept or to retain any person as a member of any group or party at any time.

Any statements made by participants or photographs taken of participants while on tour may be used by WVT in any future publicity materials or promotional publications.

I understand that WVT, its agents and employees are not responsible for any financial liability or obligation which I or the group may incur, or injury or damage to the person or property of others which I or the group may cause or contribute to while on a WVT tour.

No other refunds will be expected or sought after from the organization, church, music ministry or the above stated ISD, World View Travel (WVT) its employees and/or agents.

4. All payments for the trip will be made on time and per the following schedule. If I, the traveler, is late with a payment and have not made appropriate arrangements with **Mr. McCollough** the Director, my tour place will be forfeited to the first person on the Director's waiting list.
