- ◆ I agree to pay the uniform fee for my choir shirt and tuxedo or dress. I realize that my grades will be held if my uniform is not turned in at the end of the year.
- ◆ I agree, *if I take voice lessons*, to remit a donation of \$64 to the voice teacher at the beginning of each month for voice lessons.
- ◆ I understand that grooming must be neat, clean, and appropriate for public performances given by this organization.
- ◆ I understand that I am responsible for any materials given to me during the school year and must replace any materials that are lost or damaged. I realize that my grades will be held if lost or damaged materials are not taken care of at the end of the year.
- ◆ I understand that any money turned in must be in an envelope provided by the choir department with the appropriate information filled out on the front. I understand that checks must include a driver's license number, date of birth, and the students name in the memo line.

4. The student must acquire appropriate materials and have them at each lesson.
5. Participate in a Winter Recital for Solo & Ensemble preparation and a Spring Recital to close out the year's study.
